Environmental Responsibility:

Human Rights:

Health and Safety:

Business Ethics:

Compliance with Legal Regulations:

• Protection of Intellectual Property:

Our business partners must respect the intellectual property rights of others to protect our own or our customers' intellectual property rights, trade secrets, and personal data.

Conflicts of Interest:

We require our business partners to avoid conflicts of interest. Our employees are expected to act in the best interest of MBS AG & Co. KG. Private interests and personal considerations must not influence business decisions. Business partners may not influence or attempt to influence MBS AG & Co. KG employees through gifts, benefits, or personal advantages that exceed a modest and/or reasonable level and cannot be clearly regarded as a culturally acceptable form of business etiquette or hospitality.

Reporting Non-Compliance:

All business partners and their respective employees, as well as stakeholders and rights holders in general, are encouraged to report violations of this Supplier Code of Conduct to einkauf@mbs-ag.com.

General:
